The President welcomed all attendees in this in-person meeting of the Annual General Assembly (AGA) and thanked them for attending Euroanaesthesia 2023 in Glasgow (UK), and specifically this meeting.

59 Members with voting rights are attending this meeting and the minimum quorum of 50 attendees is reached, herewith the GA is validly constituted and can deliberate.

Activity report 2022

1. Secretary report

Our Society is recovering from the COVID pandemic and we witness an increasing trend in the number of members in our Society even though we haven't reached back the level of 2020. The Secretary also pointed out the improving gender balance, with an almost 50 - 50 ratio at the end of 2022.

2. Report of the main Committees and of the CEO

The Chairs of the main committees reported about the activities 2022. These are Education & Training, Scientific, Research and Examinations.

The activities of the other committees have already been published via a newsletter.

Then Cathy Weynants led the audience through the CEO report.

3. Presentation of the annual accounts closed per 31/12/2022 audited by the statutory auditor

As introduction, the Treasurer explained some of the challenges our Society is still facing after the COVID pandemic.

The accounts reported by the European Society of Anaesthesiology and Intensive Care for the fiscal year 2022 show a negative result of \leqslant 530.106. We achieved 92% of our budget 2022 & realized an increase in revenue of \leqslant 2.630.000 in 2022 <> 2021.

- We faced losses in previous years due to lower EA congress registrations after the pandemic but we stay strong in what we do.
- We analysed our costs very carefully & the Board decided not to cut on services for our members because we are still a financial healthy society.
- We keep investing in the key pillars of our society (research, education, exam) but we should diversify and work on new income streams.
